#### **PARTICULARS OF CLAIM**

- The First Plaintiff is MOHAMMED IQBAL SURVÉ, an adult physician and businessman, employed as Executive Chairman of Independent Media (Proprietary) Limited whose place of business is at 10<sup>th</sup> Floor, Convention Towers, Heerengracht Street, Cape Town, 8001 ("Survé").
- The Second Plaintiff is INDEPENDENT MEDIA (PTY) LTD, a private company incorporated in accordance with the company laws of the Republic of South Africa with registration number 1991/005270/07 and its registered address is situated at 10th Floor, Convention Towers, Heerengracht Street, Cape Town, 8001 ("Independent Media").
- Independent Media is a multi-platform media company, which publishes several newspapers throughout the country, including The Star in Johannesburg, The Mercury in Durban, and The Cape Times in Cape Town, as well as Independent Online, a digital online news platform.
- 4. The Third Plaintiff is INDEPENDENT ONLINE SA (PTY) LTD, a private company incorporated in accordance with the company laws of the Republic of South Africa with its registration number 2011/137399/07 and its registered address is situated at 10th Floor, Convention Towers, Heerengracht Street, Cape Town, 8001 ("IOL").
- 5. The Fourth Plaintiff is INDEPENDENT NEWSPAPERS (PTY) LTD, a private company incorporated in accordance with the company laws of the Republic of South Africa with its registration number 1989/004672/07 and its registered address is situated at 10th Floor, Convention Towers, Heerengracht Street, Cape Town, 8001 ("Independent Newspapers").
- 6. The First Defendant is **GROUNDUP NPC**, a non-profit company whose principal place of business is situated at Suite 08, 1st floor, South Block, Tannery Park, 23A Belmont Road, Rondebosch, Cape Town, 7700.

- 7. The Second Defendant is NATHAN GEFFEN an adult male and the editor of the First Defendant, whose place of employment is situated at Suite 08, 1st floor, South Block, Tannery Park, 23A Belmont Road, Rondebosch, Cape Town, 7700.
- 8. GroundUp is a news agency. Its articles are made available for republication, usually under a Creative Commons license, to news publications.
- 9. The Third Defendant is **THE DAILY MAVERICK (PTY) LTD trading as Daily Maverick**, a private company with limited liability, duly incorporated and registered according to the company laws of South Africa, with registration number 2009/015341/07, having its registered address within the jurisdiction of this Honourable Court at 3rd Floor Workshop 17, 32 Kloof Street, Gardens Cape Town, 8001.
- 10. The Third Defendant is the proprietor of a daily online newspaper entitled Daily Maverick, accessible on https://www.dailymaverick.co.za, as well as a print newspaper, the Daily Maverick.
- 11. The Third Defendant publishes a number of so-called "newsletters", including, inter alia, Business Maverick, a weekday publication containing business-related news and editorials.
- Daily Maverick is a South African online newspaper founded in 2009.

#### JURISDICTION

13. This Honourable Court has jurisdiction in respect of these proceedings on the basis that the First Defendant's and Third Defendant's business addresses, as well as the employment address of the Second Defendant, fall within its jurisdiction.

#### PLAINTIFFS' CLAIM

- 14. On 23 August 2022, the First Defendant published an article titled "Iqbal Survé's publications appear to take the side of alleged Lottery crooks". Thereafter the Third Defendant republished the said article on its website.
- 15. A copy of the article is annexed hereto marked "A" ("the article").
- 16. The article contains the following statements of and concerning the Plain tiffs:
  - 16.1. "Iqbal Survé's newspaper group has taken a curious interest in the story of corruption at the National Lotteries Commission and it appears to be taking the side of the crooks."
  - 16.2. "But in the last few weeks, there has been a spate of articles on the Lottery on Independent Online (IOL), stuffed with the usual blend of dodgy reporting and high-minded indignation."
  - 16.3. "They could have sent one of their reporters to investigate our findings about Mampane's house. They did not."
  - 16.4. "We can see where IOL's coverage on the Lottery is going accusing those exposing the crooks at the Lottery of having a racist agenda. In effect they're accusing black whistleblowers at the Lottery and black investigators at the SIU of racism..."
  - 16.5. "The "political parties" turned out to be the Economic Freedom Fighters (EFF), increasingly IOL's favoured political partner, though not known for its strong stand on corruption."
  - 16.6. "Since Survé got his hands on public money to buy the country's largest newspaper group, he has used it to publish inaccurate, often downright false, stories to further his personal interests. But in the past few weeks IOL has gone further, establishing itself as the voice that defends state capture and attacking those including journalists trying to expose state capture."

- 16.7. "This last story is especially sinister. It sends a message: if you investigate state capture, expect Survé and his propagandists to come after you."
- 17. The words quoted in paragraph 16 above, in the context of the article, are wrongful and defamatory of the Plaintiffs' in that they were intended and were understood by readers of the First and Third Defendant to mean that the Plaintiffs:
  - 17.1 are dishonest
  - 17.2 are bias and have political affiliation
  - 17.3 uses Independent Media and Independent Newspapers publications to further their own political and personal agendas to manipulate narratives
  - 17.4 corrupt or has engaged in corruption
  - 17.5 are unethical
  - 17.6 have acted illegally; and
  - 17.7 are propagandists.
- 18. The statements made of and concerning the Plaintiffs as set out above were made with the intention to defame the Plaintiffs and to injure their reputation.
- 19. Further, the words quoted above and in the context of the article, are wrongful and defamatory of the First Plaintiff in that they were intended and were understood by readers of the Third Defendant to mean that the First Plaintiff is utilising public money to fund operations within his group of companies, and thereby benefitting himself.
- 20. This allegation as aforesaid carries an additional sting as it is a personal attack on the First Plaintiff's *dignitas*.

#### DEMIAND

- 21. On the 25 August 2022, the Plaintiffs' attorneys dispatched a letter of demand to the First, Second and Third Defendants. Copies of the letters of the said correspondence is attached hereto marked "B" and "C" respectively.
- 22. The First and Second Defendants' attorneys responded and denied liability.
- 23. The Third Defendant has failed to respond to the letter of demand to date.
- 24. As a result of the defamatory statements published in the article, the Plaintiffs have been damaged in their reputation and have suffered damages in the amount of R5 000 000 (Five Million Rand) in respect of the publication and republication of the said article.

WHEREFORE the Plaintiffs' claim against the First to Third Defendants, jointly and severally:

- (a) payment of the amount of R5 000 000;
- (b) retraction of the complained article and publication of an apology on the First to Third Defendants' publication platforms.
- (b) costs of suit; and
- (c) further and/or alternative relief.



In July, GroundUp reported

(https://www.groundup.org.za/article/money-for-school-pays-for-lottery-bosss-golf-estate-home/) how the golf estate home of Lottery boss Thabang Mampane was paid for with a grant that was supposed to rebuild a Limpopo school. Our coverage may have contributed to Mampane's resignation

(https://www.groundup.org.za/article/lottery-boss-resigns-with-immediate-effect/) in August.

Independent's newspapers and IOL could have republished *GroundUp*'s articles, which are available under a Creative Commons licence. They did not. They could have sent one of their reporters to investigate our findings about Mampane's house. They did not.

Instead, the Sunday Tribune (one of Survé's newspapers) and IOL published an interview (https://www.iol.co.za/sunday-tribune/news/nlc-top-boss-charlotte-mampane-reflects-on-her-decade-long-service-704da58e-9df5-4aa5-8112-9f19cfc7d7c4) with Mampane in which she "reflects on her 10 years of service". Far from countering any of the accusations against her, she makes all sorts of claims of "political interference" in the Lottery.


#### In another IOL article

(https://www.iol.co.za/sunday-tribune/news/nlc-top-boss-charlotte-mampane-reflects-on-her-decade-long-service-704da58e-9df5-4aa5-8112-9f19cfc7d7c4), Mampane is cited as claiming "that there were journalists working with certain board members" at the National Lotteries Commission "and, in return, these journalists had received funding from the commission".

There have been only two journalists consistently working on Lottery corruption: Raymond Joseph (for *GroundUp*) and Anton van Zyl (for the *Limpopo Mirror*). They have often worked together. This extremely serious accusation of corruption is clearly aimed at one or both of them. Not a shred of evidence is offered for the claim —

because, frankly, it's absurd and there isn't any — and neither Joseph nor van Zyl were asked to respond to the allegation.

The photo is fake. It is a photo of Letwaba that was **not** taken by Joseph, superimposed on a photo of a Lotteries sign taken by Joseph. It could be an innocent error — or a way to insert Joseph's name into the article to link him to Mampane's allegation.

The same article starts: "Following the ongoing investigations and purging of mainly black executives and officials at the National Lotteries Commission ...".

We can see where *IOL*'s coverage on the Lottery is going — accusing those exposing the crooks at the Lottery of having a racist agenda. In effect, they're accusing black whistleblowers at the Lottery and black investigators at the SIU of racism. Also, the communities that have been robbed by the Lottery crooks of old age homes, schools and rehab centres are predominantly black.

And when the accusation of racism clearly won't work, *IOL* has come up with other creative solutions. Reacting to the appointment as head of the Lotteries board of Barney Pityana, one of the "elders" of South Africa's struggle and a man known for his integrity, *IOL* managed to describe him as a "pensioner".

#### In an article

(https://www.iol.co.za/dailynews/news/national-lotteries-commission-in-total-disarray-4dbc7722-ca31-4955-9c1e-02fafbc4856b) on the "disarray" at the National Lotteries Commission after the suspension of another controversial figure, chief operating officer Phillemon Letwaba, readers were told that "the appointment of pensioner Pityana as the commission's chairperson set tongues wagging with political parties and young people rejecting his appointment". The "political parties" turned out to be the Economic Freedom Fighters (EFF), increasingly *IOL*'s favoured political partner, though not known for its strong stand on corruption.

And just in case readers hadn't quite got the point, *IOL* went so **f**ar as to ask Pityana himself <u>in an interview</u>

(https://www.iol.co.za/dailynews/news/pityana-

defends-his-national-lotteries-commission-appointment-aed27d32-338c-4594-a71c-58bb31d543ed) if he didn't think he was a bit too old for the job. Pityana's response is telling: his brief, he said, was to execute his tasks efficiently and "enable resources to go where they are intended, and not end up in some people's pockets within the commission ...".

Since Survé got his hands on public money to buy the country's largest newspaper group, he has used it to publish inaccurate, often downright false, stories to further his personal interests. But in the past few weeks, *IOL* has gone further, establishing itself as the voice that defends State Capture and attacking those — including journalists — trying to expose State Capture.

It has repeated unsubstantiated allegations that the *Daily Maverick* is CIA-funded, and has run a nasty hit-job invading the privacy of a *News24* journalist who has been investigating former Eskom chief executive Matshela Koko.

This last story is especially sinister. It sends a message: if you investigate State Capture, expect Survé and his propagandists to come after you. **DM**

  - 1.4. Dr. Mohammed Iqbal Survé

2. Our instructions are that on 23 August 2022, Daily Maverick published an article authored by GroundUp Editors ("yourselves"), titled "Iqbal Survé's publications appear to take the side of alleged Lottery crooks" ('the publication").

- 3. In the publication, the following statements are, inter alia, made:
  - 3.1 "Iqbal Survé's newspaper group has taken a curious interest in the story of corruption at the National Lotteries Commission and it appears to be taking the side of the crooks."
  - 3.2 "... But in the last few weeks, there has been a spate of articles on the Lottery on Independent Online (IOL), stuffed with the usual blend of dodgy reporting and high-minded indignation."
  - 3.3 "...They could have sent one of their reporters to investigate our findings about Mampane's house. They did not."
  - 3.4 "We can see where IOL's coverage on the Lottery is going accusing those exposing the crooks at the Lottery of having a racist agenda. In effect they're accusing black whistleblowers at the Lottery and black investigators at the SIU of racism..."

  - 4.1 are dishonest
  - 4.2 are bias and have political affiliation
  - 4.3 uses Independent Media and Independent Newspapers publications to further their own political and personal agendas to manipulate narratives
  - 4.4 corrupt or has engaged in corruption
  - 4.5 are unethical
  - 4.6 have acted illegally; and
  - 4.7 are propagandists.
- The statements are wrongful and are also entirely false, as our clients have adhered to ethical journalistic practices and due diligence involved in reporting. The statements are not only baseless, but are also made grossly negligently, recklessly and/or maliciously by yourselves.
